

Wording For Your Bequest

Leaving a gift in your Will to Tape Aids For The Blind can be done easily and simply. We are always grateful to those who have included Tape Aids in their Will, in whatever form they have chosen. The following is a guide to some of the ways you can leave a Bequest.

Make Your Legacy Live On

Whether large or small, your bequest will be valued greatly because it will change the life of a person who is blind, vision impairment or has a print disability like dyslexia. Your legacy will help open whole new worlds for thousands of fellow South Africans – which is a rather remarkable gift indeed.

Types of Bequest

There are three types of bequests we recommend.

Residual bequest

This type of bequest is highly recommended as it is simply a gift of whatever is left of your Estate – or a percentage of it – after all other gifts, taxes and debts have been fulfilled. This type of bequest maintains its relative value and automatically adjusts as the value of your Estate increases.

A residual bequest puts you in control as you to decide exactly how much you want to leave to your loved ones, while leaving whatever may be left over to support our ongoing production and library operations.

How do I word it?

I Give and Bequeath to the non-profit organisation TAPE AIDS FOR THE BLIND [NPO 002-101] a registered Public Benefit Organisation [PBO 930000935] in aid of that Organisation and for its general purposes, the rest and residue of my Estate, free of all duties and testamentary expenses and I direct that the receipt of that Organisation shall be sufficient discharge to my Executors for this Bequest.

Pecuniary bequest

This is a very simple gift of a set amount of money to Tape Aids For The Blind. It is easy to set up in your Will.

How do I word it?

I Give and Bequeath to the non-profit organisation TAPE AIDS FOR THE BLIND [NPO 002-101] a registered Public Benefit Organisation [PBO 930000935] in aid of that Organisation and for its general purposes, the sum of R ______ free of all duties and testamentary expenses and I direct that the receipt of that Organisation shall be sufficient discharge to my Executors for this Bequest.

Specific bequest

A specific bequest refers to donating an item of value to Tape Aids For The Blind. This type of bequest is a good way to provide additional support to Tape Aids on top of a residual bequest, as it enables any valuable items not wanted by your loved ones to be turned into desperately needed funds for our audio book production and library services.

How do I word it?

I Give and Bequeath to the non-profit organisation TAPE AIDS FOR THE BLIND [NPO 002-101] a registered Public Benefit Organisation [PBO 930000935] in aid of that Organisation and for its general purposes, (describe the article, shares, property or other) free of all duties and testamentary expenses and I direct that the receipt of that Organisation shall be sufficient discharge to my Executors for this Bequest.
